In compliance with requirements of legislation and associated regulations, a robust coordination plan that engages local authorities and emergency services is in place, in order to **prevent** and **manage** any unexpected incidences.

Delphi Economic Forum IX commitment to Health & Safety

Delphi Economic Forum IX with the support of **GEP**, has activated an assiduous health prevention and management plan, ensuring that all attendees are provided with the **highest level** of health and safety provisions.

Kindly note that the following principles will ensure you have an **optimal Delphi Economic Forum experience**.



01 Medical Emergencies Management

- ✓ **Any medical emergency will be safely, timely and efficiently managed** by GEP's Health Professionals, present at all sites throughout the event.
- ✓ **Automated External Defibrillators, first aid medical equipment and patient-care consumables** will be available onsite by GEP.
- ✓ Any medical emergency that requires **ambulance transportation** will be handled by dedicated EMS, either by Athens Medical Group health services or EKAB.
- ✓ **Rescue staff** will provide pre-hospital care, first aid stabilization or ambulance transportation if needed.

02 Provision of a State-of-the-Art Hall

- ✓ **Catering operations** will run in a safe and hygienic way, eliminating any potential food related hazards.
- ✓ Suitable arrangements have been made, wherever possible to ensure **that all people with special needs are able to attend**.
- ✓ Sufficient resources, policies and infrastructure are in place to **optimize your experience** in terms of health and safety.

03 Healthy & Safe behaviors to preserve your welfare

- ✓ **Apply Hand Hygiene and Respiratory Etiquette** by frequently washing your hands, using a hands sanitizer and cover your mouth and nose when sneezing or coughing.
- ✓ While first aid medications will be available by **GEP**, you are strongly advised to **bring with you any prescribed and necessary medications** you normally take.
- ✓ An **escape and evacuation plan signage** has been designed by **GEP** and is in place, ensuring that you have the necessary support if evacuation is required.
- ✓ All exit routes will be clearly indicated. Take a moment to **spot emergency access routes** at each venue. They will be kept unobstructed at all times.
